What does judging involve?

Judging takes place over 2 stages. Each stage is designed to provide rigorous yet fair assessment against clear criteria. HSJ publishes the below dates, and all our judges are sent instructions at each stage and asked to meet deadlines.

2nd October 2023	Entries open for submission
17th Jan 2024 – 21st Feb 2024	STAGE 1 JUDGING – Remote scoring. Each judge will be given 5 weeks to score a max of 25 entries a score out of 50 over 5 criteria
18th March 2024	Announcement of the HSJ Digital Awards finalists
29th April 2024 – 6th May 2024	STAGE 2 JUDGING - The finalists present to our panel of judges; this will be conducted virtually and will be an all-day event. (Exact dates for each category below)
6th June 2024	Awards Ceremony at Manchester Central

Stage 1 judging is completed remotely

- Judges will have 5 weeks to complete this stage
- Each judge will have a maximum of 25 entries to review
- Each entry is approximately 2000 words plus supporting material
- An estimate of 30 mins per entry is suggested
- Feedback will be provided to all entrants' post event

Stage 2 judging will take place after the official finalist announcement and only those on the final short list will be invited to present to panels of senior healthcare leaders. The exact dates for each category are outlined below.

- The project leads and teams of each finalist will present to the judging panel virtually
- After each 10-minute presentation judges will have 10 – 15 minutes to question the team
- At the end of the day judges will be invited to choose their winning project, team, organisation, or leader for that category
- This stage will take place virtually. This will be an all-day event.
